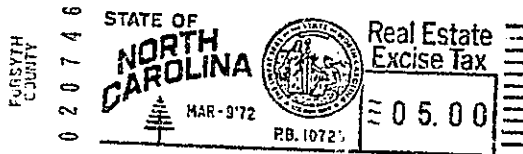
THIS DEED, made this 1st day of March, 1972, by J & J ASSOCIATED DEVELOPERS, INC.

~~that said party of the first part in consideration of~~ of the second part, receipt of which is hereby acknowledged, has bargained and sold and by these presents does bargain, sell and convey to said parties of the second part and their heirs and assigns, a certain tract or parcel of land in Township, Forsyth County, North Carolina, bounded as follows:

BEGINNING at a stake in the southwest corner of the E. T. Nance, Sr. property, thence along a chord N 89° 44' W 147.65 feet to a stake; thence along a chord S 88° 38' W 152.26 feet to a stake, the new southwest corner of J & J Associated Developers, Inc. underdeveloped land; thence N 13° 01' E 415.34 feet to a stake; thence S 49° 41' E 100.00 feet to a stake; thence S 21° 11' E 359.00 feet to a stake; thence S 02° 52' E 2.78 feet to a stake, the point of BEGINNING; containing 1.58 acres, more or less. The same being part of the property described in Deed Book 1025, at page 321, in the Office of the Register of Deeds of Forsyth County, North Carolina, and being known and designated as that property as surveyed and mapped by Franklin Surveying Company on January 18, 1972.
