CORPORATION DEED

THIS DEED, made this 3rd day of December, 19 70, by A & B TAX SERVICE, INC.

a Corporation of Winston-Salem, Forsyth County,
 North Carolina, party of the first part, to W. RAYMOND JONES and his wife, LORRAINE FOUST JONES
 of Forsyth County, North Carolina, parties of the second part, WITNESSETH:

That said party of the first part in consideration of Ten Dollars (\$10.00 O.V.C.) and other valuable considerations to it paid by parties of the second part, receipt of which is hereby acknowledged, has bargained and sold and by these presents does bargain, sell and convey to said parties of the second part and their heirs and assigns, a certain tract or parcel of land in Winston Township, Forsyth County, North Carolina, bounded as follows: BEGINNING at an iron stake at the Northwest corner of Lot No. 8 of the Charles E. Ebert Property, running thence South 3° 53' West 505 feet to a stake, Southwest corner of Lot No. 8; thence North 87° 10' West 65 feet Southwest corner of Lot No. 7; thence North 3° 35' East 451 feet to Sprague Street; thence North 54° 15' East 85 feet to the place of BEGINNING. Being known and designated as Lot Number Seven of the Property of C. E. Ebert Estate as surveyed by C. M. Miller, C.E., which map is of record in the Office of the Register of Deeds of Forsyth County, North Carolina, in Plat Book 10, page 174(2) to which map reference is hereby made for a more accurate description. For further reference see Deed Book 654, page 48.

This conveyance is made subject to the grantees assuming and agreeing to pay that certain note and deed of trust from A & B Tax Service, Inc. to Johnnie Mae Lennon Swaim recorded in Deed of Trust Book 1007, page 338, on which there remains a balance due of \$16,310.99.

TO HAVE AND TO HOLD the aforesaid tract, parcel or lot of land, all privileges and appurtenances thereto belonging to the said parties of the second part and their heirs and assigns, to their only use and behoof forever;
 AND THE SAID party of the first part covenants to and with the said parties of the second part and their heirs and assigns, that it is seized of said premises in fee, and has right to convey the same in fee simple; that the same are free from all encumbrance, and that it will warrant and defend the said title to the same against the claims of all persons whatsoever.
