North Carolina, party of the first part, to EDWARD W. KELLY and wife, LINDA W. KELLY and GLENN E. SWAIM, JR.
and wife, LYNN W. SWAIM of Forsyth County, North Carolina, part IES of the second part. WITNESSETH:That said party of the first part in consideration of TEN DOLLARS AND OVER VALUABLE CONSIDERATIONS
(\$ 10.00 & OCV) and other valuable considerations to it paid by part ies of the second part, receipt of which is hereby acknowl-
edged, has bargained and sold and by these presents does bargain, sell and convey to said part ies of the second part and their heirs and
assigns, a certain tract or parcel of land in Clemmonsville Township, Forsyth County, North Carolina, bounded as follows:
Beginning at an iron stake the Southwest corner of a tract of land conveyed to
the Grantors herein as described in Deed Book 1025 at page 321, said iron stake
also being a corner with E. T. Nance, Sr. and Mrs. E. A. Nash; and running thence
with the East line of said Nance, North 24° 30' East 130.0 feet to a point;
thence on a new line with the Grantors herein South 61° 05' East 336.38 feet
to a point, thence on another new line with the said grantors herein, South 32°
30' West 120.0 feet to a point in the North line of property owned by W. H.
Lamberti; thence with the North line of said Lamberti, North 60° 10' West
215.0 feet to an iron stake the Northwest corner of said Lamberti, said iron
stake also being the Northeast corner of the said Nash property; thence with
the North line of the said Nash property North 68° 22' West 104.74 feet to
