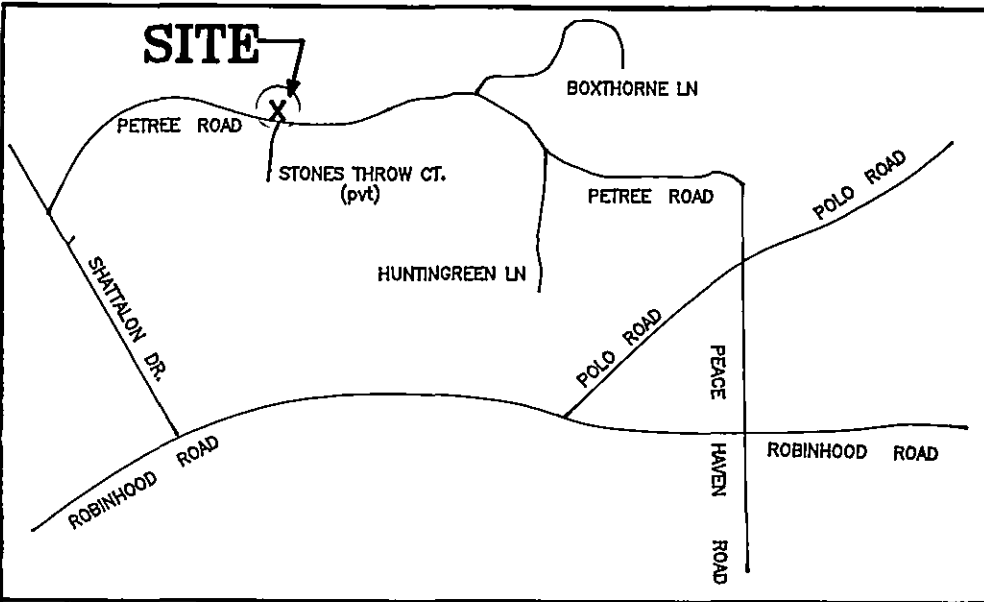




LOCATION MAP

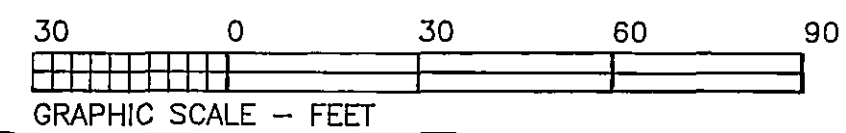
