has hereby released and forever quitclaimed, unto A & A Realty Company

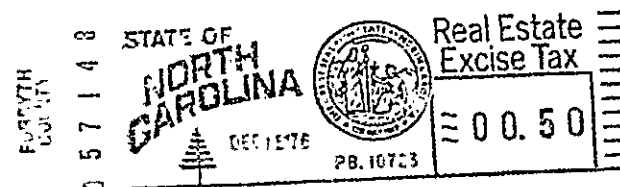
