If, however, there shall be any defaut in any of the terms or conditions of the note secured hereby, or of the terms, concost of the Grantors. If, however, there shall be any defaut in any of the terms or conditions of the note secured hereby, or of the terms, conditions or covenants contained in this deed of trust, or in the event of actual or threatened demolition or injury or waste to the premises which may impair the value of the property hereby conveyed, or if a receiver should be appointed for, or a petition in bankruptey filed by or against the Grantors, or either of them, then and in any of such events, the note shall, at the option of the Bank, become at once due and payable, regardless of the maturity date thereon, and on the application of the Bank it shall be lawful for and the duty of the Trustee, and he is hereby authorized and empowered to expose to sale and to sell the hereinhefore described premises and personal property, if any, at public sale for eash, after having first published notice of such sale, containing the information required by law, at least once a week for four consecutive weeks preceding such sale in a newspaper published in the county aftersaid, the last publication not more than seven days preceding the date of sale and upon such sale, the Trustee shall convey title to the purchaser in fee simple. After retaining five per cent (5%) of the proceeds of such sale as compensation to the Trustee and after retaining all expenses incurred by him, including reasonable attorney's fees for legal services actually performed, the Trustee shall apply the residue of the proceeds, first to the payment of all sums expended by the Bank under the terms of this deed of trust, second, to the payment of the note and interest thereon secured hereby, and the balance, if any, shall be paid to the parties entitled to same according to law. The Grantors covenant and agree that they will pay when due all taxes, assessments, levies, and charges upon or against the property herein described, and will keep the improvements and the buildings now or hereafter on said premises insured against loss and damage by fire, tornado and windstorm, and against such other hazards as the Bank may require, including business interruption, in amounts satisfactory to the Bank, plus amounts sufficient to prevent any co-insurance liability of the owner of the property or the Bank, for the benefit of the Bank, loss, if any, to be made payable in the policy or policies of insurance to the Bank as its interest may appear, the loss payable clauses to be in such form as the Bank may require. All insurance shall be of such types as the Bank may, from time to time, require and shall be in companies approved by the Bank, and the policies and renewals thereof shall, when issued, be immediately delivered to the Bank to be held by it. The proceeds of any insurance, or any part thereof, may be applied by the Bank, at its option, either to the reduction of the indebtedness here y secured or to the restoration or repair of the property damaged. The Bank may, at its option, pay any insurance premiums, taxes, assessments, levies, or charges against the premises. In case such insurance premiums, taxes or other assessments, levies or charges shall be at any time paid by the Bank, the amounts so expended shall immediately become debts due by the Grantors, shall bear interest at the maximum legal rate per annum, and their payment shall be secured by this deed of
