S & J Homebuilders, a general partnership

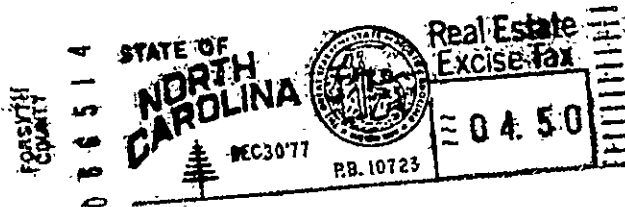
