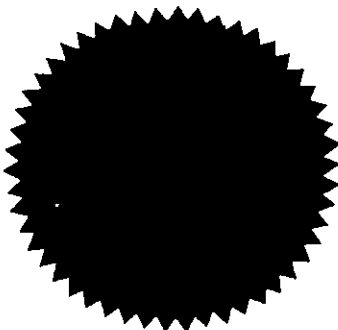

ARTICLES OF AMENDMENT TO THE CHARTER
OF
E & A CONSTRUCTION COMPANY, INC.

The undersigned Corporation hereby executes these Articles of Amendment for the purpose of amending its Charter:

1. The name of the Corporation is E & A Construction Company, Inc.
2. An amendment to the Charter of the Corporation was adopted by its shareholders by written consent to Action Without Meeting on the 27th day of January, 1980, in the manner prescribed by law, the amendment revoking Article I of the Articles of Incorporation and substituting in lieu thereof the following:

The name of the Corporation is BOB HEMRICK CONSTRUCTION CO., INC.
3. The number of shares of the Corporation outstanding at the time of such adoption was 300 shares; and the number of shares entitled to vote thereon was 300.
4. The number of shares voted for such amendment was 300; and the number of shares voted against such amendment was zero (0).
5. The amendment herein effected does not give rise to dissenter's rights to payment for the reason that the only effort of such amendment is to change the name of the Corporation.
