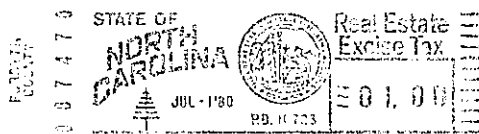
THIS DEED Made this the 25th day of April, 19 80 by A & H Properties, a general partnership,
