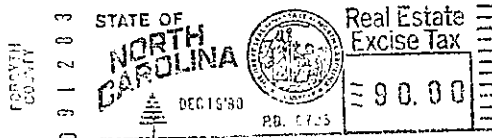

THIS CORPORATION DEED, made this 11th day of December 1980, by BOB HEMRICK CONSTRUCTION CO., INC. (formerly known as E & A CONSTRUCTION CO., INC.) a Corporation of Winston-Salem, Forsyth County, North Carolina, party of the first part, to PAUL W. McINNISH, SR. and wife, DORIS J. McINNISH of Forsyth County, North Carolina, parties of the second part, WITNESSETH: that said party of the first part in consideration of TEN DOLLARS (\$10.00 o.v.c.) and other valuable considerations to it paid by parties of the second part, receipt of which is hereby acknowledged, has bargained and sold and by these presents does bargain, sell and convey to said parties of the second part and their heirs and assigns, a certain tract or parcel of land in Clemmons Township, Forsyth County, North Carolina, bounded as follows:

BEING KNOWN AND DESIGNATED as Lot Number 266, as shown on the Plat of Clemmons West, Section 8A, as recorded in Plat Book 27, page 115, in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description.



TO HAVE AND TO HOLD the aforesaid tract, parcel or lot of land, all privileges and appurtenances thereto belonging to the said parties of the second part and their heirs and assigns, to their only use and behoof forever;

AND THE SAID party of the first part covenants to and with the said parties of the second part and their heirs and assigns, that it is seized of said premises in fee, and has right to convey the same in fee simple; that the same are free from all encumbrance, and that it will warrant and defend the said title to the same against the claims of all persons whatsoever, save and except easements and restrictions of record and 1980 taxes.
