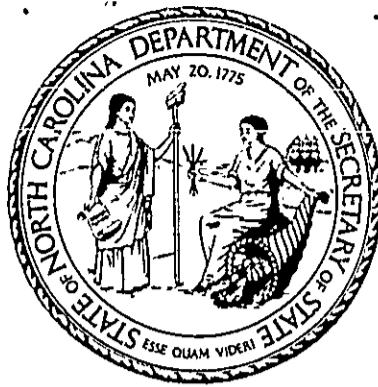

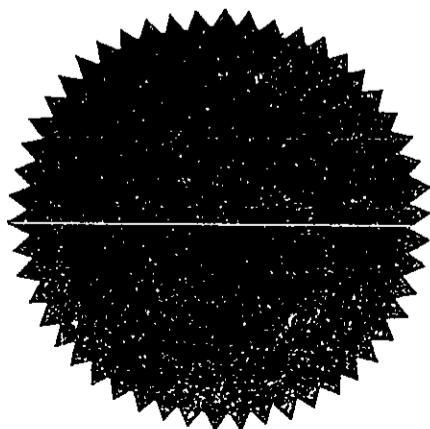

ARTICLES OF INCORPORATION

THAD EURE  
SECRETARY OF STATE

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

1. The name of the corporation is V & F Enterprises, Incorporated.
2. The period of duration of the corporation is perpetual.
3. The purpose for which the corporation is organized is to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
4. The aggregate number of shares which the corporation shall have authority to issue is 100,000 without par value.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Dollar (\$1.00) in cash or property of equivalent value.
6. The address of the initial registered office of the corporation in the State of North Carolina is 4040 Winchester Road, Winston-Salem, Forsyth County, North Carolina 27106; and the name of its initial registered agent at such address is John D. Versaggi.

7. The number of directors constituting the initial board of directors shall be two (2); and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders, or until their successors be elected and qualify, are:

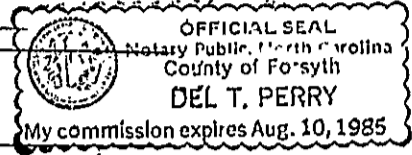
