

We, the undersigned, being natural persons of the age of eighteen (18) years or more, for the purposes of forming a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled Business Corporation Act, and the several amendments thereto, hereby set forth our Articles of Incorporation as follows:

ARTICLE ONE NAME

The name of the corporation is: Q C ENGRAVING, INC.

ARTICLE TWO PERIOD OF DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE THREE

The purpose or purposes for which the corporation is organized are:

- A. To engage in the business of engraving and marking metals, plastics, and woods for signs, jewelry, identifications and other uses, using various traditional modes for such engraving along with a computerized engraving and cutting system to accomplish said work.
- B. To sell such engraved work at either wholesale or retail price through direct sales contacts or through consignment or ownership of a retail sales store.
- C. To have and exercise all the powers now or hereafter conferred by the laws of the State of North Carolina upon Corporations organized pursuant to the laws under which the Corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE FOUR CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is ONE HUNDRED THOUSAND (100,000).

SHARES and all shall be classified as common, and shall have no series, class or preference. Such shares shall have no par value.

ARTICLE FIVE CONSIDERATION FOR SHARES

The minimum number of shares to be sold by the corporation before it shall commence business shall be FIVE THOUSAND (5000) SHAPES and the minimum amount of consideration received for each of such shares shall be the sum of ONE (\$1.00) DOLLAR.

ARTICLE SIX REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the corporation is 4670 Elk Valley Court, Winston-Salem, Forsyth County, North Carolina 27103, and the name of the initial registered agent at such address is WILLIAM FRANK QUIETT.

ARTICLE SEVEN

The number of Directors of the Corporation may be fixed by the by-laws, but shall not be less than two (2) except as permitted by statue.

The number of Directors constituting the initial Board of Directors shall be two (2), and the name and address of each person who is to serve as director until the first meeting of the shareholders or until his successor is elected are as follows:
