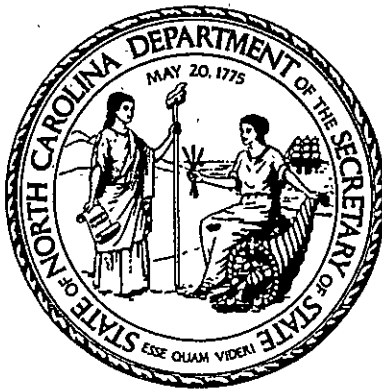

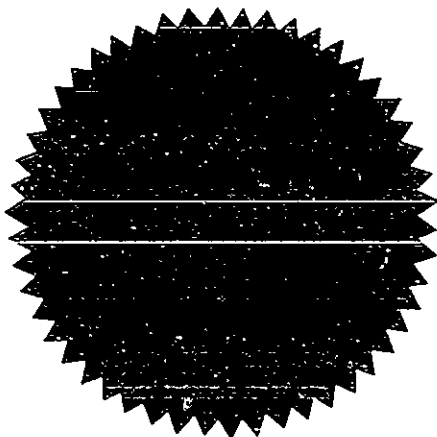

ARTICLES OF AMENDMENT
TO THE CHARTER OF
H PROPERTIES, INC.

JUN 1 2 50 PM '83

The undersigned Corporation hereby executes these Articles of Amendment for the purpose of amending its Charter:

SECRETARY OF STATE
NORTH CAROLINA

1. The name of the Corporation is H Properties, Inc.
2. The following amendment to the Charter of the Corporation was adopted by its shareholders on the 1st day of June, 1983, in the manner prescribed by law:
 1. The name of the Corporation is X Company.
 3. The number of shares of the Corporation outstanding at the time of such adoption and the number of shares entitled to vote thereon was 100.
 4. The designation and number of outstanding shares of each class entitled to vote on such amendment as a class were as follows:

Common Stock	20
Preferred Stock	80

5. One Hundred (100) shares voted for such amendment and no shares voted against such amendment. Voting within each class entitled to vote as a class was as follows:

6. The Amendment herein effected does not give rise to dissenter's rights to payment for the reason that the only effect of such amendment is to change the corporate name.
