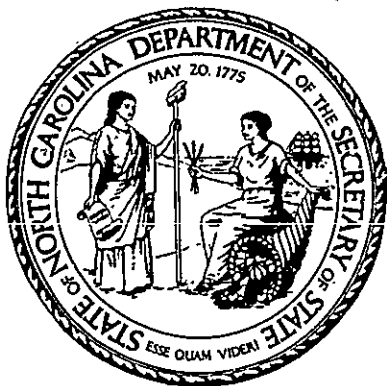

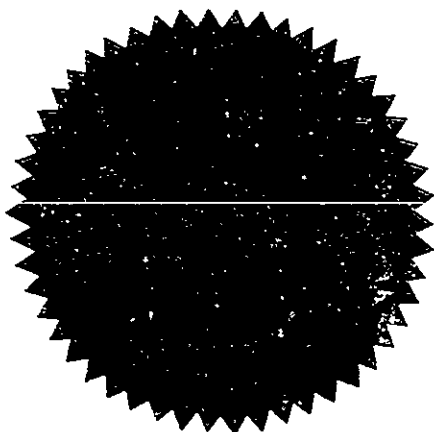



## ARTICLES OF INCORPORATION

OF

J & C Floyd Enterprises, Inc.  
(NAME OF CORPORATION)

We, the undersigned natural persons of the age of eighteen years or more, do hereby associate ourselves into a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end do hereby set forth:

1. The name of the Corporation is J & C Floyd Enterprises, Inc.

2. The period of duration of the corporation shall be perpetual  
(May be perpetual or for a limited period)

3. The purpose or purposes for which the corporation is organized are:

To engage in the purchases, sales, and rentals of all types  
of buildings.

Also, to engage in any lawful acts or activities permitted by  
law for such a corporation.

4. The aggregate number of shares which the corporation shall have authority to issue is 100,000, divided into one classes. The designation of each class, number of shares of each class, series, if any, within each class, and the par value, if any, of the shares of each class, or a statement that the shares of any class are without par value, is as follows:

The preferences, limitations and relative rights in respect of the shares of each class are as follows:

5. The minimum amount of consideration for its shares to be received by the corporation before it shall commence business is \$ 200.00.

Winston-Salem, North Carolina 27106 (Forsyth),  
and the name of the initial registered agent at such address is Jerome E. Floyd

7. The number of directors of the corporation may be fixed by the by-laws, but shall not be less than three (except as permitted by N.C.G.S. 55-25).

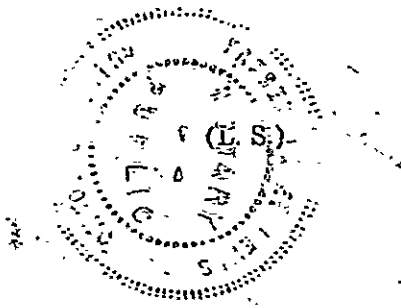
