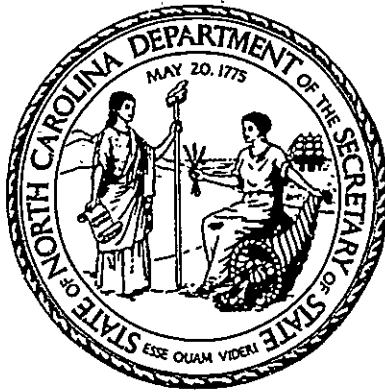

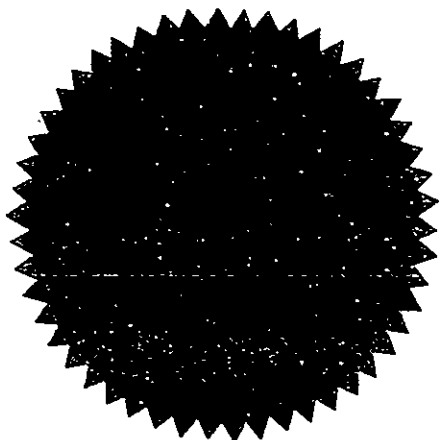

ARTICLES OF INCORPORATION

J & G TRANSPORTATION, INC.

The undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

1. The name of the corporation is J & G Transportation, Inc..

2. The period of the duration of the corporation is perpetual.

3. The purposes for which the corporation is organized are:

(a) To broker and otherwise provide transportation services; and

(b) To engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.

4. The corporation shall have the authority to issue 100,000 shares with a par value of \$1.00 per share.

5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Hundred (\$100.00) in cash or property of equivalent value.

6. The shareholders of the corporation shall have no preemptive right to acquire additional or treasure shares of the corporation.

7. The address of the initial registered office of the corporation within the State of North Carolina is Suite 522, NCNB Plaza, Winston-Salem, Forsyth County, North Carolina; and the name of its initial registered agent at such address is Michael R. Greeson, Jr.

8. The number of directors constituting the initial Board of Directors shall be two (2); and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders, or until their successors be elected and qualify, are:

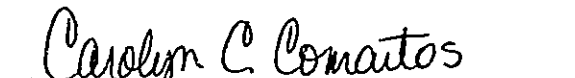

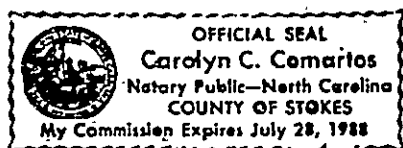
