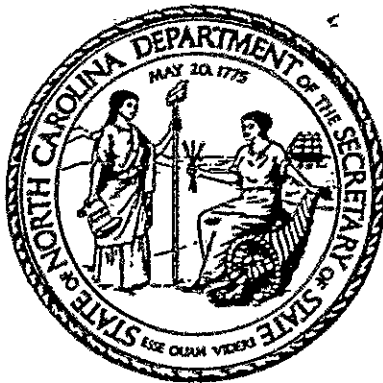

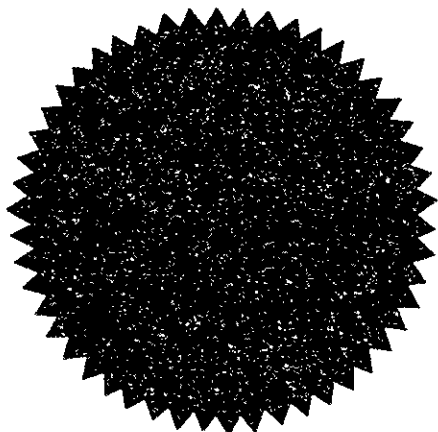

The name of the corporation is CALLOWAY MAINTENANCE, INC.

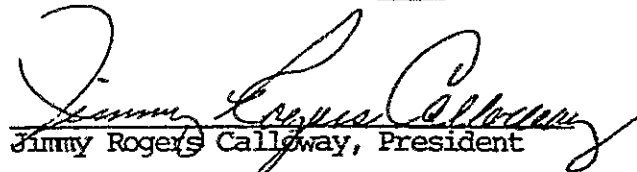
2. The amendment to the Articles of Incorporation is as follows:

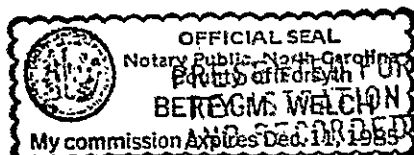

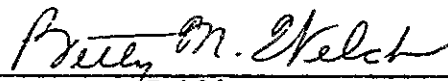
