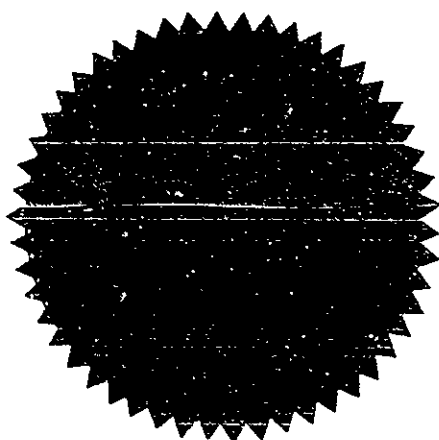

The undersigned corporation hereby executes these Articles of Amendment for the purpose of amending its charter:

1. The name of the corporation is Timber and Metal Sales Company, Inc.

2. The following amendment to the charter of the corporation was adopted by its shareholders on the 16th day of April, 1985, in the manner prescribed by law:

"Article 1 of the Charter of the Corporation is amended to read as follows:

The name of the corporation is
T and M Sales, Inc."

3. The number of shares of the corporation outstanding at the time of such adoption was 11,000; and the number of shares entitled to vote thereon was 11,000.

4. The number of shares voted for such amendment was 11,000; and the number of shares voted against such amendment was 0.

5. The amendment herein does not give rise to dissenter's rights to payment for the reason that the only effect of such amendment is to change the name of the corporation.
