ARTICLES OF INCORPORATION

I, the undersigned, being a person of full age, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and be virtue of the laws of the State of North Carolina.

I.

The name of the corporation shall be J & G Provence Trucking Co., Inc.

II.

The period of duration of the corporation shall be perpetual.

III.

The purposes for which the corporation is organized are:

(a) To buy, sell, hold, rent and lease equipment, such as but
