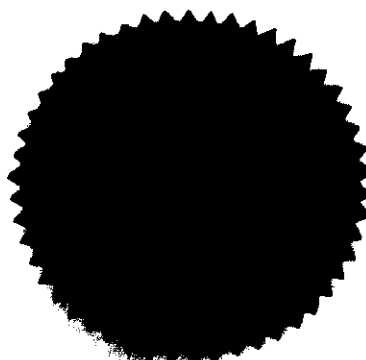

The undersigned natural person of the age of twenty-one (21) or more does hereby make and acknowledge these Articles of Incorporation, for the purpose set forth below, under and by virtue of the laws of the State of North Carolina:

1. The name of the Corporation is W. HOLBROOK, INC.
2. The duration of the Corporation is perpetual.
3. The Corporation is organized pursuant to Chapter 55 of the General Statutes of North Carolina.
4. The Corporation is organized to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
5. The Corporation shall have authorized One Hundred Thousand (100,000) shares of stock, with One Dollar (\$1.00) par value, all of which shall be fully paid and nonassessable common stock of one and only one class.

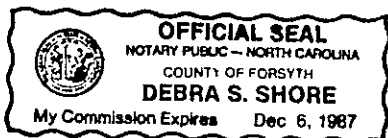
