CONDOMINIUM WARRANTY DEED

FORSYTH COUNTY :

THIS CONDOMINIUM WARRANTY DEED made this the 23rd day of June, 1989, by J & F PARTNERS, a North Carolina Partnership, hereinafter referred to as "Grantor," to STEPHEN C. LEVERTON, hereinafter referred to as "Grantee."

W I T N E S S E T H :

The Grantor, in consideration of the sum of Ten Dollars and Other Valuable Considerations (\$10.00 & O.V.C.) to it paid by the Grantee, receipt of which is hereby acknowledged, has bargained and sold, and by these presents does hereby bargain, sell, and convey unto the Grantee, his heirs, successors and assigns, that property in the County of Forsyth and State of North Carolina comprising a portion of the condominium known as COBBLESTONE CONDOMINIUM, SECTION TWO, said condominium having been established by Declaration of Condominium dated October 6, 1982, and recorded in Book 1376, Page 106, in the Office of the Register of Deeds of Forsyth County, North Carolina on October 18, 1982, and as amended by "Amendment to Declaration of Condominium of COBBLESTONE CONDOMINIUM, SECTION TWO" dated December 1, 1983, and recorded December 7, 1983, in Book 1421, Page 925, in the Forsyth County Registry, and being more particularly described as follows:

FIRST: Unit No. 2309-B, Building No. 2309, of COBBLESTONE CONDOMINIUM, SECTION TWO, recorded in Condominium Book 2, Pages 32 through 35, inclusive, in the Office of the Register of Deeds of Forsyth County, North Carolina.

SECOND: An undivided 8.812 percentage interest in and to the "Common Areas and Facilities" as referred to in said Declaration of Condominium, appurtenant to the aforesaid Unit, said "Common Areas and Facilities" being more particularly described in the Declaration of Condominium and amendments thereto and in the plans of COBBLESTONE CONDOMINIUM, SECTION TWO, recorded in Condominium Book 2, Pages 32 through 35, inclusive, in the Office of the Register of Deeds of Forsyth County, North Carolina.

TOGETHER WITH all rights and easements appurtenant to said Unit as specifically enumerated in said Declaration of Condominium and amendments thereto, the Articles of Incorporation and By-Laws of COBBLESTONE CONDOMINIUM, SECTION TWO, recorded simultaneously with said Declaration of Condominium and subject to regular and special assessments, limitations and restrictions contained in said Declaration of Condominium and said Articles of Incorporation and respective By-Laws. Included in said restrictions is a prohibition of use of the Unit for nonresidential purposes.

TOGETHER WITH an easement of egress and ingress and for use of utility easements as contained in Book 1326, Page 1649, in the Forsyth County Registry.

TO HAVE AND TO HOLD the aforesaid property, and all privileges and appurtenances thereunto belonging together with the aforesaid rights of easements and use in and to the Common Areas and Facilities subject to said Declaration of Condominium and said Articles of Incorporation and respective By-Laws.

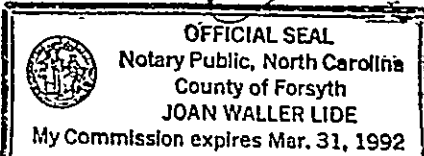
