MEMORANDUM AND CERTIFICATE OF PARTNERSHIP AGREEMENT

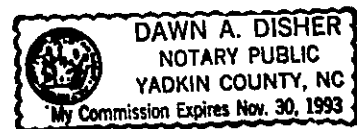
