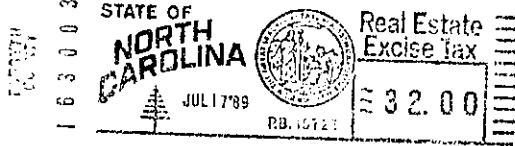

# NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 30th day of June, 19 89, by and between

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the City of Lewisville, Lewisville Township, Forsyth County, North Carolina and more particularly described as follows:

BEING KNOWN AND DESIGNATED as Lot Numbers 6 and 15 as shown on the Map of HARPERS CROSSING recorded in Plat Book 33 at Page 13 in the Office of the Register of Deeds of Forsyth County, North Carolina; reference to which is hereby made for a more particular description..

The property hereinabove described was acquired by Grantor by instrument recorded in .....

TO HAVE AND TO HOLD the aforesaid lot or parcel of land and all privileges and appurtenances thereto belonging to the Grantee in fee simple.

And the Grantor covenants with the Grantee, that Grantor is seized of the premises in fee simple, has the right to convey the same in fee simple, that title is marketable and free and clear of all encumbrances, and that Grantor will warrant and defend the title against the lawful claims of all persons whomsoever except for the exceptions hereinafter stated. Title to the property hereinabove described is subject to the following exceptions:

- a) Real property taxes for the year 1989 and subsequent years.
- b) Restrictive covenants and easements of record, if any.

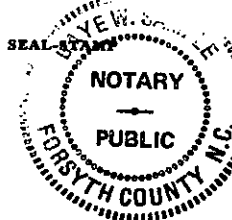
