

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF NEWELL ACQUISITION COMPANY

The undersigned Corporation hereby executes these Articles of Amendment for the purpose of amending its Articles of TATE Incorporation:

- 1. The name of the Corporation is: Newell Acquisition Company.
- 2. The following amendments to the Articles of Incorporation of the Corporation were adopted by its Shareholders on the 3/ day of August, 1989, in the manner prescribed by law:
- (A) Article 1. of the Articles of Incorporation is amended to read as follows: "The name of the Corporation is "Q C Engraving, Inc."
- 3. The stated capital shall not be changed by these Articles of Amendment and shall remain the same.
- 4. The number of shares of the Corporation outstanding at the time of such adoption was 20,000 and the number of shares entitled to vote thereon was 20,000.
