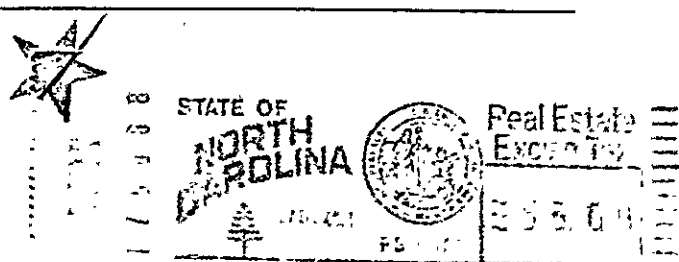

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantor, in consideration of (\$ 10.00 o.v.c.) Ten Dollars o.v.c. to her
paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot
or parcel of land in Forsyth County, North Carolina _____ Township, more particularly described as follows:

BEING KNOWN and designated as Lot No. 123 on a plat entitled "Sherwood West, Section 5-A" recorded in Plat Book 25, at page 148, in the Office of the Register of Deeds of Forsyth County, North Carolina; and

TOGETHER with all rights and easements appurtenant to said Lot as specifically enumerated in the Declaration of Covenants, Conditions and Restrictions issued by Westminster Company and recorded in Deed Book 1133, at page 1623, in the Office of the Register of Deeds of Forsyth County, North Carolina; and membership in Sherwood West Association, Inc.

THE GRANTEE herein hereby assumes and covenants to perform all the terms and conditions of the obligations set forth in that certain promissory note executed by Lynn M. Hale and delivered to The Pfefferkorn Company in the amount of Forty-Three Thousand Nine Hundred and No/100 Dollars (\$43,900.00) dated May 22, 1986, and that certain deed of trust securing said promissory note of even date therewith, upon the property conveyed in the deed, which deed of trust is recorded in Book 1543, page 2027.

Subject to easements and restrictions of record, if any. This conveyance is made specifically subject to the deed of trust to The Pfefferkorn Company which the Grantee has agreed to assume and pay.

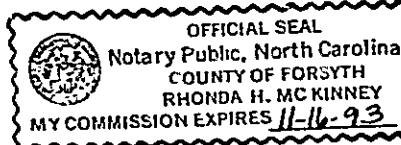
