DEED OF RELEASE

THIS DEED OF RELEASE, made and entered into this 22 day of July, 1991, by and between E&M PROPERTIES, INC., as Noteholder; KELLY V. HAZLETT, as Trustee, and GINA RUTH DOMBALIS (Single), JOHN J. PATELLA and wife, SUE H. PATELLA, as Grantee. The designation Noteholder, Trustee and Grantee as used herein shall include the designated parties, their heirs, successors and assigns and shall include the singular, plural, masculine, feminine or neuter as required by context.

W I T N E S S E T H :

WHEREAS, the Grantee heretofore executed a certain Deed of Trust as recorded in Book 1698, at Page 4195, Forsyth County, North Carolina, Registry, to secure a note therein described and payable to the Noteholder or the Noteholder's predecessor in interest; and

TO HAVE AND TO HOLD the lands and premises, together with all privileges and appurtenances thereto belonging to them, the Grantee and their heirs, successors and assigns, free and discharged from the lien of the Deed of Trust described above; but it is agreed and understood that this release shall apply only to so much of the property as is herein expressly described and conveyed, and that as to the remainder of said property, the Deed of Trust shall be and remain in full force and effect.

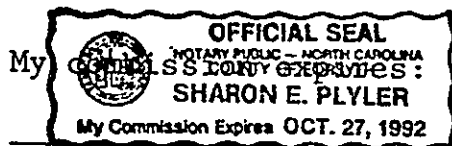

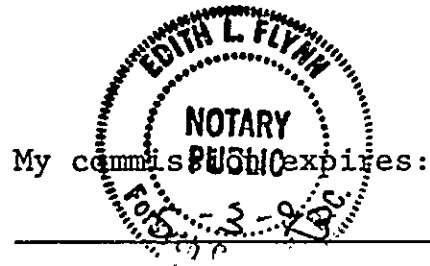
