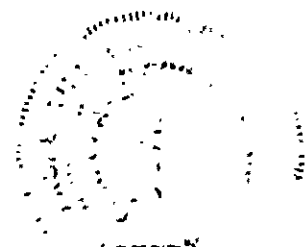

CONSENT TO DEDICATION

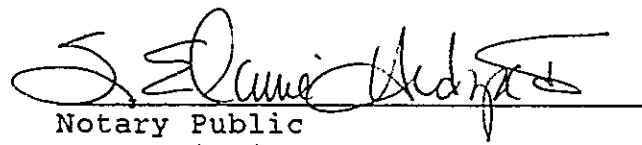

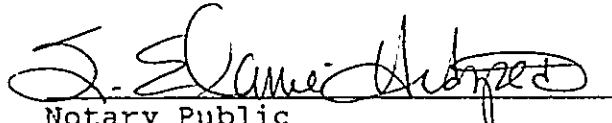

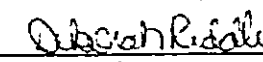
