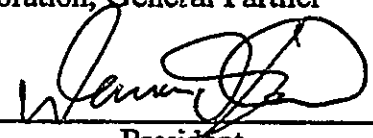
The first full paragraph appearing on Page 2 of Exhibit A to the referenced UCC Financing Statement is hereby amended and restated to read as follows:

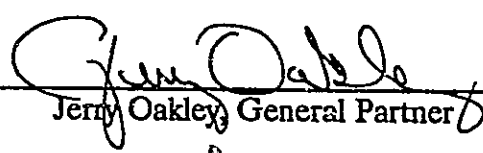

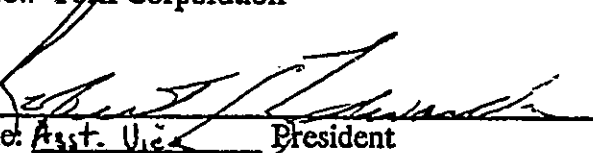
