LEASE

FORSYTH COUNTY )

THIS CONTRACT made and entered into this the 28th day of August, 1992, by and between RONALD L. ATKINS, party of the first part, and A & C METAL PRODUCTS COMPANY, INC., party of the second part, both of Forsyth County, North Carolina;

W I T N E S S E T H:

THAT subject to the terms and conditions herein set out, said party of the first part does hereby let and lease unto said party of the second part, and said party of the second part does hereby accept as tenant of said party of the first part certain buildings together with the lands they are located on at the corner of Dacian Street and Waughtown Street, known as 700 Waughtown Street and 704 Waughtown Street, Winston-Salem, North Carolina, and more particularly described in Deed Book 1152 at Page 496 of and Deed Book 1152 at Page 210, of the Forsyth County, North Carolina, Registry.

The terms and conditions of this lease being as follows:

This lease shall begin as of the 1st day of September, 1992, and unless sooner terminated as herein provided, shall exist and continue for a period of five years from date with the privilege of renewing in additional five year increments provided the parties can agree on what the rental payments should be for the next five year period. The Lessee may exercise its option to renew by notifying the party of the first part of its intent thirty days prior to the expiration of any five year period.

The rental to be paid by said party for said premises during the term of this lease shall be payable monthly in advance on the first day of each calendar month as follows:

Rent on 700 Waughtown Street	\$1,600.00
Rent on 704 Waughtown Street	<u>1,200.00</u>
TOTAL	\$2,800.00

It is, however, agreed that if any monthly installment of rent as herein called for be and remain overdue and unpaid for 30 days, at any time during said default the party of the first part may at his option

terminate this lease and demand and receive possession of said premises.

The party of the second part agrees to accept said premises in their present condition and agrees during the term of this lease to make such repairs and renovations as may be necessary to maintain said premises in their present condition and suitable for use in the business of the party of the second part and agrees to surrender the premises at the termination of this lease in their present condition, ordinary wear and tear excepted.

In addition to the foregoing, the tenant shall be responsible for the payment of all utilities and hazard insurance on the premises in the amount of \$ \_\_\_\_\_, with the Lessor names as loss payee, as his interest may appear.

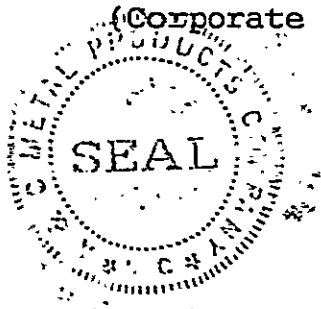

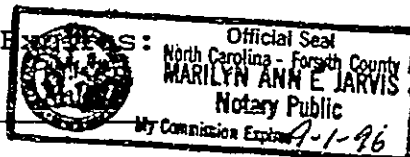
