SUBORDINATION AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that STEPHEN L. GOOGE and wife, SUSAN L. GOOGE, are the present holders and owners of a certain Note secured by a Deed of Trust executed by T & A AUTOMOTIVE ENTERPRISE, INC., a North Carolina corporation to Norman L. Nifong, Trustee for STEPHEN L. GOOGE and wife, SUSAN L. GOOGE recorded in Book 1731 at Page 3305 in the Office of the Register of Deeds of Forsyth County, North Carolina establishing a lien upon a certain tract or parcel of land located in Forsyth County, North Carolina and described as follows:

FOR DESCRIPTION see EXHIBIT "A" attached hereto and incorporated herein by reference as if fully set forth in its entirety herein.

NOW, THEREFORE, STEPHEN L. GOOGE and wife, SUSAN L. GOOGE, in consideration of the sum of One Dollar (\$1.00 & OVC) and Other Valuable Considerations to them in hand paid, do hereby contract and agree with T & A AUTOMOTIVE ENTERPRISE, INC. that it may execute to William P. Baldridge, Trustee a Deed of Trust upon the above-described property, to secure a Note given by T & A Enterprise Automotive, Inc. to Nationsbank of North Carolina, N. A. in the sum of One Hundred Sixty-Five Thousand and No/100 (\$165,000.00) Dollars and that the said Deed of Trust shall be a lien upon the above-described property superior to the lien of the existing Deed of Trust of STEPHEN L. GOOGE and wife, SUSAN L. GOOGE; and, to carry out the said purpose, STEPHEN L. GOOGE and wife, SUSAN L. GOOGE do hereby release, remise, and forever quitclaim unto T & A AUTOMOTIVE ENTERPRISE, INC., their title to and lien upon the above-described property to the extent, but to the extent only, that the existing Deed of Trust shall be subordinate in lien to a Deed of Trust to William P. Baldridge, Trustee in the amount of One Hundred Sixty-Five Thousand and No/100 (\$165,000.00) Dollars.

BUT IT IS EXPRESSLY UNDERSTOOD AND AGREED that except for such subordination, the existing Deed of Trust and any and all singular terms and conditions thereof shall be and remain in full force and effect.
