The designation Designated Grantor, Trustee and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that whereas the Designated Grantor, on the 16th day of August, 19 90, made and executed to the Trustee, a Deed of Trust recorded in Book 1698 Page 4195 upon the lands hereinafter described, and whereas the Designated Grantor failed to comply with the terms of said Deed of Trust, (and whereas William A. Hough, III was duly appointed Substitute-Trustee by instrument recorded in Book 1755 Page 3099); and whereas the said Trustee in compliance with the terms of said Deed of Trust exposed said lands to public sale to the highest bidder, after due advertisement, on the 23rd day of December 19 92, at the Courthouse door in Winston-Salem, when and where the Grantee became the highest bidder at the sum of Fifty One Thousand Three Hundred Seventy Six and 13/100 Dollars.
NOW, THEREFORE, for and in consideration of the premises and the sum of \$51,376.13 Dollars in hand paid to the said Trustee, by the said Grantee, the receipt whereof is hereby acknowledged, the said Trustee does by these presents hereby sell and convey unto the said Grantee and his successors, heirs and assigns forever, the following tract and lot of land lying in Forsyth County, North Carolina, and more particularly described as follows:

All of the property described in that certain Deed of Trust recorded at Book 1698, Page 1495 of the Forsyth County Deed Registry except those portions of said property conveyed to BWV, Inc. and to Gary Phillips respectfully by Deeds recorded in the Forsyth County Registry at Book 1749, Page 0677 and Book 1719, Page 2406.

TO HAVE AND TO HOLD the aforesaid lot or parcel of land, to the said Grantee, to Grantee's use and behoof forever; and the Trustee covenants with the Grantee, that the Trustee is seized of said premises and has right to convey the same and that he will warrant and defend the title to the same in so far as it is his duty to do so by virtue of his said office as Trustee and no further.
