

TRACT #1: BEING known and designated as Lot Number 292 as shown on the Map of Reynolds Place as recorded in Plat Book 1, Page 48, in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description, save and except any portion of the same, if any, now lying within the right of way of Waughtown Street. The Eastern 5 foot strip of this lot was acquired by Marilyn W. Smith by inheritance through her father, John Wesley Willard who died intestate in Forsyth County, NC on May 11, 1959, see Administrator's File #6227, and her stepmother, Bernice J. Willard, who held a dower interest, has by quitclaim deed conveyed all her right, title, interest and estate to Marilyn W. Smith. Being Tax Lots 292A and 292B, Block 926, Forsyth County Tax Maps.

TRACT #2: BEING known and designated as Lot Number 293 as shown on the Map of Reynolds Place as recorded in Plat Book 1, Page 48, in the Office of the Register of Deeds of Forsyth County, North Carolina, to which reference is hereby made for a more particular description. This conveyance is subject to an easement to the City of Winston-Salem as recorded in Deed Book 435, Page 252, which permits discharge of water from Waughtown Street across subject property. Subject also to any portion of the above property lying within the right of way of Waughtown Street. There is excepted from this conveyance that portion of Lot 293 heretofore conveyed to Gary D. Phillips by deed recorded in Book 1719, Page 2406, Forsyth Registry. Being Tax Lot 293B, Block 926, Forsyth County Tax Maps.
