DEED OF SUBORDINATION

THIS DEED OF SUBORDINATION is entered into this the  $27^{H}$  day of May, 1993, by W & M BUILDERS, INC., hereinafter referred to as "Noteholder", and ROBERT E. PRICE, JR., hereinafter referred to as "Trustee", and BERTHA J. COPELAND, as "Grantee";

### WITNESSETH:
