DEED OF EASEMENT

245

This Deed of Easement made and entered into this the 29th day of November, 1993 by and between A & L Development Inc. (grantor) and Susan Howard Park (grantee).

WITNESSETH

Whereas A & L Development Inc. is owner and developer of a subdivision known as Mystic Glen as recorded in Plat Book 35 at pages 49 and 50, Plat Book 35 at Page 60 and is currently the owner of Lot 3 of Mystic Glen.

Whereas Susan Howard Park is now owner of Lot 4 of Mystic Glen.

Whereas a survey attached hereto as Exhibit A has indicated a potential encroachment of a drive from Lot 3 onto Lot 4.

Whereas A & L Development Inc. wishes to convey a right of easement for said driveway.

Therefore in consideration of and for consideration received and acknowledged as sufficient, A & L Development Inc. does hereby grant an easement for ingress, egress and regress over that portion of a drive which encroaches upon Lot 3 from Lot 4 of Mystic Glen. Maintenance of said drive shall be sole responsibility of owner of Lot 4.

This easement shall run with the land and shall be binding on the purchasers, grantees, heirs or assigns of current and future owners of Lot 3 of Mystic Glen.

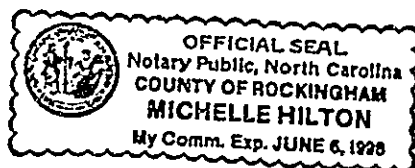

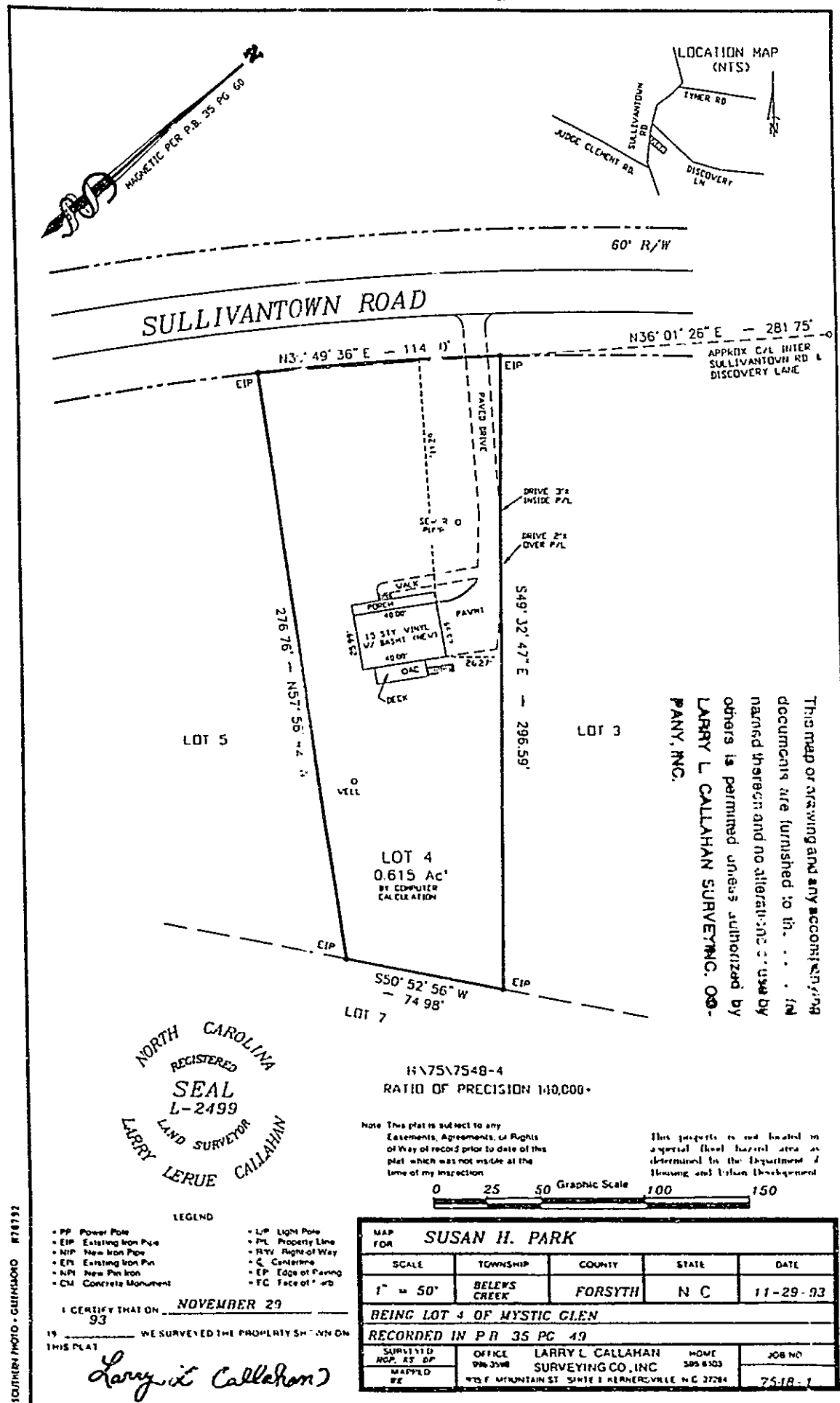
