Township, Forsyth County, North Carolina, and more particularly described as follows:

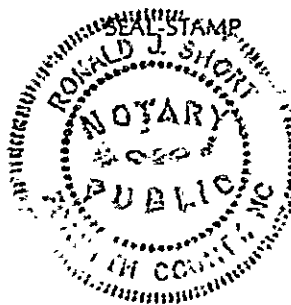
