- 7. Guaranty Agreement from The Kroger Co. dated August 10, 1995 ("Kroger Guaranty").

(The Note, Loan Agreement, Deed of Trust, Assignment of Leases, Assignment of Construction Documents, Midland Guaranty, and Kroger Guaranty, are hereafter collectively referred to as "Loan Documents."); and

WHEREAS, All parties herein desire to increase the principal amount of the loan from Six Million Three Hundred Five Thousand and  $^{10}/100$  Dollars (\$6,305,000.00) to Six Million Eight Hundred Nineteen Thousand and  $^{10}/100$  Dollars (\$6,819,000.00); and

WHEREAS, Midland Guarantors and the Kroger Guarantor were and are liable for the obligations under the Note and other Loan Documents as set forth in their respective Guaranty Agreements (limited as set forth therein with respect to the Kroger Guaranty) and wish to evidence their continuing obligation for the increased amount by consenting to the modifications contained herein.

NOW THEREFORE, for valuable consideration, the receipt of which is hereby acknowledged, Borrower, Lender, Substitute Trustee, Midland Guarantors and Kroger Guarantor hereby agree as follows:

- 1. The Note and all other Loan Documents are hereby amended so that the maximum principal amount of the Loan is Six Million Eight Hundred Nineteen Thousand and ∞/100 Dollars (\$6,819,000.00).

Notwithstanding the last sentence in paragraph 18 entitled "Transfer of Premises" in the Deed of Trust, Lender agrees to release any of the five (5) out parcels shown on plats entitled "Kernersville Shopping Center" and labeled as Lot 2 in Map Book 39 at Page 46, Lots 4 and 5 in Map Book 39 at Page 55 and Lots 6 and 7 in Map Book 39 at Page 56 all of the Forsyth County Public Registry, upon payment of 100% of the net sales proceeds generated from the sale of the same. As used herein, "net sales proceeds" shall mean the gross sales proceeds derived from an arms length transaction approved by Lender less normal and customary closing costs and normal and customary commissions paid to third parties by Borrower.

Borrower hereby ratifies and confirms that the Note and other Loan Documents evidence and secure a valid and subsisting obligation of Borrower and that there are no defenses or offsets against the same, and except as amended herein, are agreed to be in full force and effect by all parties in accordance with their respective terms.
