AMENDMENT TO LOAN DOCUMENTS

<u>WITNESSETH</u>

THAT WHEREAS, Lender has heretofore agreed to loan to Borrower up to Six Million Eight Hundred Nineteen Thousand and no/100 Dollars (\$6,819,000.00) ("Loan") which is evidenced and secured by the following documents:

- 1. Promissory Note and Security Agreement in favor of Lender dated August 10, 1995 ("Note").
- 2. Loan Agreement between Borrower and Lender dated August 10, 1995 ("Loan Agreement").
- Deed of Trust to Richard F. Dunlap, Jr. as Trustee for Lender dated August 10, 1995 recorded in Book 1868 at Page 3702 in the Forsyth County Public Registry ("Forsyth Deed of Trust").
- 4. Assignment of Lessor's Interest in Lease between Borrower and Lender dated August 10, 1995 recorded in Book 1868 at page 3709 of the Forsyth County Public Registry. ("Assignment of Leases").
- 5. Assignment of Construction Documents between Borrower and Lender undated ("Assignment of Construction Documents").
- 6. Unconditional Guaranty dated August 10, 1995 from Midland Guarantors ("Midland Guaranty").



- 7. Guaranty Agreement from The Kroger Co. dated August 10, 1995 ("Kroger Guaranty").
- 8. Amendment to Loan Documents executed by all parties dated December 19, 1996 and recorded in Book 1934 at Page 799 in the Forsyth County Public Registry ("First Amendment").

(The Note, Loan Agreement, Deed of Trust, Assignment of Leases, Assignment of Construction Documents, Midland Guaranty, Kroger guaranty, and First Amendment are hereinafter collectively referred to as "Loan Documents."); and

WHEREAS, it is anticipated that an outparcel encumbered by the Deed of Trust will be sold ("Biscuitville Sale") and the "net sales proceeds" (as the same is defined in the First Amendment) will be applied to the principal balance of the Loan; and

WHEREAS, after the principal reduction from the Biscuitville Sale, Borrower and Lender wish to readvance in accordance with the provisions of the Loan Agreement up to Four Hundred Thousand and no/100 Dollars (\$400,000.00) for items set forth on the revised budget approved by Lender; and

WHEREAS, in addition to the modifications set forth above, Lender will require an additional principal reduction of \$400,000.00 by April 30, 1997 (limited, however, to the amount readvanced in accordance with the terms of this Amendment); and

WHEREAS, Midland Guarantors and the Kroger Guarantors were and are liable for the obligations under the Note and other Loan Documents as set forth in their respective Guaranty Agreements (limited as set forth therein with respect to the Kroger Guaranty) and wish to evidence their continuing obligation for the increased amount by consenting to the modifications contained herein.

NOW THEREFORE, for valuable consideration, the receipt of which is hereby acknowledged, Borrower, Lender, Substitute Trustee, Midland Guarantors and Kroger Guarantor hereby agree as follows:

- 1. The Note and all other Loan Documents are hereby amended so that subsequent to the "net sales proceeds" being applied to the principal balance of the Loan from the Biscuitville Sale, Lender may advance and readvance up to Four Hundred Thousand and no/100 Dollars (\$400,000.00) for line items as set forth on the revised budget approved by Lender and for all further advances and readvances shall be secured by the Loan Documents.
- 2. All interest accruing from the date hereof, shall be paid by the Borrower directly and shall not be funded from the proceeds of the Loan.

- 3. In addition to the anticipated principal reduction from Biscuitville Sale, Borrower shall also be required to make an additional principal payment in an amount of \$400,000.00 no later than April 30, 1997 (limited to the amount readvanced in accordance with the provisions of this Amendment). Failure to do so shall constitute an Event of Default under the Loan Documents.
- 4. Borrower agrees to have any letters of credit issued in favor of Lender regarding the Loan renewed or extended at least two (2) weeks prior to their scheduled expiration. Failure to do so shall constitute an Event of Default.
- 5. Borrower hereby ratifies and confirms that the Note and other Loan Documents evidence and secure a valid and subsisting obligation of Borrower and that there are no defenses or offsets against the same, and except as amended herein, are agreed to be in full force and effect by all parties in accordance with their respective terms.
- 6. The Midland Guarantors and Kroger Guarantor join in the execution hereof to ratify and confirm that the Midland Guaranty and the Kroger Guaranty are in full force and effect and continue to guarantee the obligations (as may be limited therein) contained in the Note and other Loan Documents as amended herein.
