KNOW ALL MEN BY THESE PRESENTS, that I, PATSY REDDING SHOEMAKER, of Forsyth County, North Carolina, have made, constituted, and appointed my spouse, JACK DONALD SHOEMAKER, of Forsyth County, North Carolina, my true and lawful attorney in fact for me and in my name, place and stead, for the purposes herein set out.

1. Generally to manage and attend to all my affairs, interests, and property of whatever kind and character, real, personal, and mixed, wherever situated. Specific authorizations to said attorney as set out herein are not intended to be exclusive or to limit the generality of his power and authority and discretion to perform any and all acts whatever kind necessary to be done in managing and attending to all my affairs, property, and interests as aforesaid, in the same manner and to the same extent as I, myself might or could do if I were personally present; the said specific powers are as follows:

(a) To make, either in person or in writing, or both, all tax returns of whatever kind required of me, including state, federal, county, and municipal tax returns, and to sign and acknowledge upon oath any and all such tax returns.

(b) To maintain anywhere in his discretion bank accounts and safe deposit boxes for me; to have full access to any bank account or safe deposit box that I may have heretofore established or rented or may hereafter establish or rent, wherever the same may be located, including but not limited to the right to make deposits in and withdrawals from any of said bank accounts, and to place property in and remove property from any of said safe deposit boxes. This paragraph shall be in full effect for the complete protection of any bank affected until such time as I may give such bank written notice of its revocation.

(c) To receive and/or collect all my income of whatever kind.

(d) To pay my just and legitimate obligations of whatever kind, and to incur obligations as he deems proper.

(e) To give and sign, and to receive receipts; to endorse any commercial paper; to compromise, adjust and settle any note, mortgage, deed of trust or other obligation due me or owned by me; to credit payment of or cancel any note, mortgage, deed of trust or other obligation due me upon proper payment being made, whether in full or by way of compromise or settlement as aforesaid.

(f) To retain, improve, lease, transfer, assign or sell any property or interests of whatever kind, real, personal or mixed, belonging to me in such a manner and for such a price and upon such terms as he may deem fit and proper, and to receive such money or other payment as may be due thereby; without limiting the generality of the foregoing, to sell, assign, endorse, transfer upon the books of the company, and to receive payment for any stock standing in my name in any corporation, and to sell, assign, transfer and receive payment for any registered bond standing in my name, or any unregistered bond.

(g) To borrow money in my behalf if he deems the same necessary or desirable, to give notes or other evidences of debt therefore and to pledge, mortgage, or otherwise encumber as security therefore any of my property of any kind, real, personal or mixed, that he considers desirable or necessary, all in his sole and absolute discretion.

(h) To invest and reinvest without restriction any of my money or other property of whatever kind coming into his possession, whether income or principal, in such a manner as he may deem fit and proper in his sole discretion.

(i) To execute any and all deeds or other instruments or papers of whatever kind that may be useful or necessary to carry out any of the powers and authorities granted in any portion of this Power of Attorney.

(j) To make such arrangements and pay or expend for my benefit, such amounts of income or principal as he determines in his sole discretion reasonable or proper to provide for my suitable maintenance, support, comfort, health and welfare; and to allow such members of my family as he determines, to use my personal effects, and household furniture, or to store the same, or to sell and dispose of the same. All of the above powers are to be exercised as determined in the sole discretion of my attorney and all such discretionary powers exercised and all decisions made shall be binding upon me and all persons and for all purposes.

(k) To effect all transactions in his name as attorney in fact or in my name.

(l) All investments and reinvestment shall be made for such purposes as my attorney in fact shall, from time to time, deem to be in my best interests.

(m) I hereby give and grant to my spouse, JACK DONALD SHOEMAKER, my attorney in fact, full power and authority to do and perform each and every act and thing whatsoever requisite and necessary to be done in and about the premises as fully and to all intents and purposes as I might or could do if personally present, and I hereby ratify and confirm all that the said attorney in fact shall do or cause to be done by virtue hereof.

2. No person, firm, corporation, or agency, governmental or otherwise, paying money or delivering property of whatever kind to my said attorney shall be under any obligation whatever to look to the disposition of such money or property by said attorney.

3. This Power of Attorney is a Durable Power of Attorney as defined in North Carolina General Statute 32A-B and is executed pursuant to the provisions of Article 2 of Chapter 32A of the General Statutes of North Carolina. This Power of Attorney shall not be affected by my subsequent incapacity of mental incompetence. I hereby direct my attorney in fact to register this instrument in the Office of the Register of Deeds of Forsyth County, North Carolina, and in such other public registry as my attorney in fact shall deem necessary or appropriate in order for said attorney in fact to exercise the authority herein granted.

4. My attorney in fact shall not be required to file any inventory or any accounting with any court or any person. Pursuant to North Carolina General Statute 32A-11(b), I specifically waive the rendering of inventories and accounts by my attorney in fact.


