The Borrower and any other person or entity signing below hereby waive any right or claim they may have against the Beneficiary/Bank in connection with the Note, any collection activities of the Beneficiary/Bank with respect to the Note (including, without limitation, any foreclosure activities) and statements, if any, of the Beneficiary/Bank to credit reporting agencies or others with respect to the delinquencies or defaults which may have occurred before the date hereof and Borrower acknowledges and agrees that it is bound to repay the principal account referenced above without offset or deduction according to the terms of the Note as modified by this Agreement.
