WITNESSETH that the Grantor, in consideration of Ten Dollars and Other Valuable Consideration (\$10.00 & OVC) to them paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, that certain lot or parcel of land, lying and being in Forsyth County, North Carolina; and being more particularly described as follows:

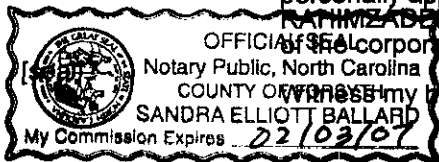
SUBJECT to all easements, rights of way and restrictive covenants of record, if any, and taxes for the year 2004, which have been prorated to date of closing.
