THIS DEED made this 23<sup>rd</sup> day of August, 2005, by and between **ELAINE M. ZABANEH** (hereinafter referred to as "Grantor"), and **MARWAN M. ZABANEH and AMAL Z. That the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does remise, release and forever quitclaim unto the Grantee in fee simple, subject, however, to the right retained by the Grantor unto herself and exercisable under her will which makes specific reference to this right, to appoint the property described herein to any person or trust other than herself, her estate, her creditors, the creditors of her estate, or any trust for the benefit of her, her estate, her creditors, or the creditors of her estate, such conveyance to be any and all of the Grantor's right, title, claim, and interest in those certain premises situated in Forsyth County, North Carolina, and more particularly described as follows:

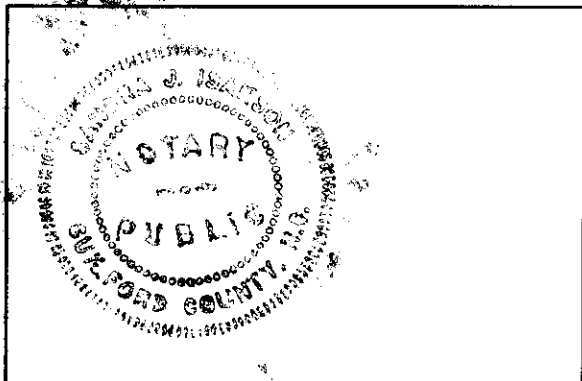
