Re: Deed of Trust executed by Z House R-E, LLC (incorrectly identified as Zevely House Real Estate, LLC) and Zevely House Real Estate, LLC (collectively, “Grantor”), to SCBT, Inc., Trustee, for the benefit of Southern Community Bank and Trust (“Bank”), recorded in Book 2041, Page 584 Forsyth County Registry

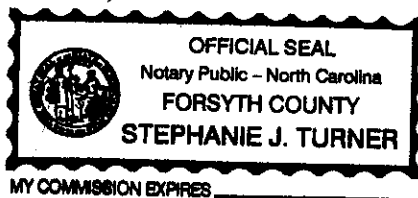

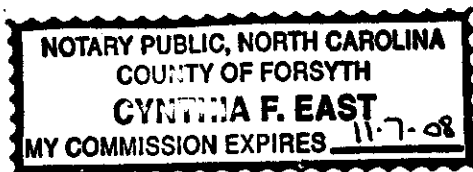
