Forsyth County Register of Deeds, Forsyth County, North Carolina.**

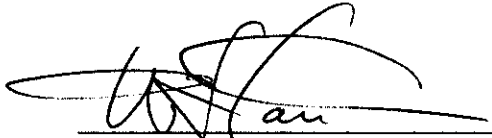
The property hereinabove described was acquired by Grantor by instrument recorded in
