CROSS DEFAULT AND CROSS COLLATERALIZATION AGREEMENT

THIS CROSS DEFAULT AND CROSS COLLATERALIZATION AGREEMENT ("Agreement") is entered into by FS FT. LAUDERDALE, LLC, FS GEORGIA, LLC, FS WINSTON-SALEM, LLC, FS LOG CABIN, LLC and FS KINSTON, LLC (jointly and severally, the "Existing Borrowers") and FS DAYTONA, LLC ("New Borrower") for the benefit of REGIONS BANK ("Lender") effective _________, 2009.

RECITALS:

- A. Existing Borrowers are indebted to Lender pursuant to existing credit facilities in the respective amounts of \$1,500,000.00 ("Ft Lauderdale Loan"), \$2,000,000.00 ("Georgia Loan"), \$3,200,000.00 ("Winston-Salem Loan"), \$400,000.00 ("Log Cabin Loan") and \$1,050,000.00 ("Kinston Loan") (collectively, "Existing Loans").
 - B. The Existing Loans are secured by mortgages or deeds of trust as follows:

- 4. In addition to securing the respective Existing Loans, the Security Documents shall also secure the New Loan as if originally secured thereunder. Each respective Existing Borrower warrants and represents that other than the lien of the respective Security Document, there are no other liens, judgments, mortgages or deeds of trust encumbering the real property being cross collateralized hereunder other than taxes which are not yet due and payable.
