WITNESSETH:

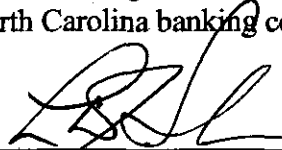

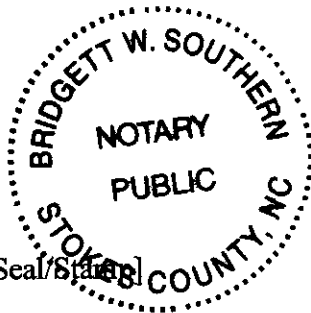
