   )         **WARRANTY DEED**

THIS FIRST AMENDMENT TO WARRANTY DEED (this "Amendment") is made effective as of the 15<sup>th</sup> day of October, 2010, between the CITY OF WINSTON-SALEM, a North Carolina municipal corporation ("Grantor") and Y-STAIR APARTMENTS, LLC, a North Carolina limited liability company ("Grantee").

### RECITALS:

A. Grantor has executed and delivered to Grantee, a Warranty Deed dated November 13, 2009 and recorded November 13, 2009 in Book 2921, Page 309, Forsyth County Register of Deeds (the "Deed") conveying ownership in certain real property (the "Property"), as described more particularly in the Deed, from Grantor to Grantee.

B. The Deed provides that upon the happening of certain events prior to the issuance of certificates of occupancy for the completion of certain improvements on the Property, then Grantor has the right to re-enter and take possession of the property.

C. The parties now desire to amend one of the provisions contained in the Deed to acknowledge that the Grantor is allowed a transfer of certain of the membership interests in Grantee from Blackpine Development Corporation to a to-be-formed affiliated limited liability company, Blackpine Investments, LLC.

NOW, THEREFORE, in consideration of the promises contained herein, Grantor and Grantee agree as follows:

1. The phrase "or any change in the ownership or distribution of the stock of the GRANTEE, or with respect to the identity of the parties in control of the GRANTEE or the

2. degree thereof," in Section (3) at the bottom of the first page of the Deed is hereby amended and restated in its entirety to read "or any change in the ownership or distribution of the stock of the GRANTEE, or with respect to the identity of the parties in control of the GRANTEE or the degree thereof, other than a transfer of certain of the membership and all of the manager interests in the GRANTEE from Blackpine Development Corporation to Blackpine Investments, LLC,".

3. Except as expressly set forth herein, the Deed shall remain unchanged, in full force and effect and unaffected hereby.

IN WITNESS WHEREOF, Grantor and Grantee have caused this Amendment to be executed effective as of the date first above written.

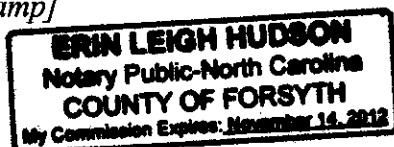


