THIS DEED, made this 14th day of May, 2012, by and between Borin Leng, and wife, Sokheang Sun, and Narith Leng, f/k/a Sovannarith Leng, and wife, Kolarb E, GRANTORS herein, and Narith Leng and wife, Kolarb E, as tenants by the entirety, GRANTEES herein. (The designation Grantor and Grantee as used herein include said parties, their heirs, successors and assigns, and shall include singular, plural, masculine, feminine and neuter as required by context.)

WITNESSETH, that the Grantors, in consideration of love and affection and ten dollars and other valuable consideration (\$10.00 o.v.c.) to them paid by the Grantees, the receipt and sufficiency of which are hereby acknowledged, have and by these presents do grant, bargain, transfer, sell and convey unto the Grantees in fee simple as tenants by the entirety, all that certain tract, lot, or parcel of land in Forsyth County, North Carolina, and being more particularly described as follows:

BEING KNOWN AND DESIGNATED as Lot No. Fifteen (15) as shown on Map of Konnoak Acres, Section 1, recorded in Plat Book 19, at page 97, in the Office of the Register of Deeds of Forsyth County, North Carolina, to which plat reference is hereby made for a more particular description.

TO HAVE AND TO HOLD the aforesaid lot or parcel of land and all privileges and appurtenances thereto belonging to the Grantees in fee simple as tenants by the entirety. And the Grantors covenant with the Grantees, that Grantors are seized of the premises in fee simple, have the right to convey the same in fee simple, that title is marketable, free and clear of all encumbrances, and that Grantors will warrant and defend the title against the lawful claims of all persons whomsoever, subject to the following exceptions: all easements, rights of ways, restrictive covenants, of record, if any, and ad valorem taxes for the year 2012.
