A certain Second Deed of Trust and Assignment of Rents, Profits and Income (Multifamily) (the "Deed of Trust"), dated May 14, 1991, was made and executed by Falcon Pointe Limited Partnership, a limited partnership (therein "party of the first part"), Larry J. The aforementioned debt evidenced by the Note and secured by the Deed of Trust has been fully paid and satisfied. In consideration thereof, the Beneficiary hereby releases and discharges any and all liens held by the Beneficiary with respect to the debt evidenced by the Note and secured by the Deed of Trust.
