POWER OF ATTORNEY

KNOW ALL PERSONS BY THESE PRESENTS that I, LUIS V. PARRA QUIROGA ("Principal") have made, constituted and appointment and by these presents do make, constitute and appoint LUDY ESPERANZA LIZARAZO SIERRA, as my true lawful Attorney-in-Fact ("Attorney"), to act in and with the same powers and authority that I now possess or with which I may be subsequently endowed, as hereinafter set forth:

1. Capacity. I, LUIS V. PARRA QUIROGA, am older than eighteen (18) years of age and I am mentally competent.

3. Duration. 5. Strict Conformity. The provisions of said section 32A-8 **et-seq.** of the General Statutes relating to the registration of this Power of Attorney shall be strictly complied with.

This limited Power of Attorney does not impose a duty on my Agent to exercise granted powers, but when a power is exercised, my Agent shall use due care to act in my best interests and in accordance with this document. My Agent and my Agent's state, heirs, successors and assigns are hereby released and forever discharged by me, my estate, my heirs, successors and assigns and personal representatives from liability and from all claims or demands of all kinds arising out of the acts or omissions of my Agent pursuant to this document, except for willful misconduct or gross negligence.
