LIMITED POWER OF ATTORNEY FOR REAL PROPERTY**

**GRANT OF AUTHORITY**

The authority of my agent to act on my behalf pursuant to this power of attorney will automatically expire **Ninety (90) days from the date hereof.** Actions taken by my agent on my behalf pursuant to this power of attorney while this power of attorney remains in effect shall continue to bind me even after my agent's authority expires.

#### RELIANCE ON THIS POWER OF ATTORNEY


Any person, including my agent, may rely upon the validity of this power of attorney or a copy of it unless that person knows it has terminated or is invalid.


