EXHIBIT A (Legal Description)

BEGINNING at a point on the north side of Fourth Street ninety-nine and five one-hundredths feet (99.05') Westerly from the northwest corner of Fourth and Liberty Streets, it being (now or formerly) E.W. O'Hanlon's southwest corner, running thence Northerly with O'Hanlon's line forty-five and fourteen one-hundredths (45.14'), thence Easterly with O'Hanlon's line nine and three one-hundredths feet (9.03'); thence Southerly with O'Hanlon's line eleven and one-tenth feet (11.1'); thence Easterly with O'Hanlon's line and parallel or nearly so with Fourth Street ninety feet (90') to the west side of Liberty Street; thence Northerly along the westerly side of Liberty Street Sixty-Six and seven one-hundredths feet (66.07'), more or less to the southerly side of an alley (now or formerly) known as Plank Road Alley; thence Westerly along the southerly side of said alley one hundred and twenty-four and twenty-five one-hundredths feet (124.25') to a point on the south side of said alley at the northeast corner of (now or formerly) A.F. Sams' property; thence Southerly along Sams' line one hundred feet and thirty eight one-hundredths of a foot (100.38'), more or less to the northerly side of Fourth Street, it being Sams' southeast corner; thence with the north side of Fourth Street in an easterly direction twenty-six and two-tenths feet (26.2') to the place of beginning.
